The Cincinnati Bell Extended Territories LLC d/b/a altafiber connected services (CBET) Hamilton Ohio DRM Switch HMTNOHHMDC3 located in Hamilton, Ohio will be retired and removed from the CBET network. Traffic served by this switch is migrated to the CBET MetaSwitch 2 EVDLOHEVPS2 for DS0 Trunks and EVDLOHEVPS7 for T1 and T3 Trunks, both located in Evendale, Ohio

#### Description of type of changes planned:

The Cincinnati Bell Extended Territories LLC d/b/a altafiber connected services (CBET) switch HMTNOHHMDC3 located at 222 South 2<sup>nd</sup> Street, Hamilton, Ohio 45013 will be retired and removed from the CBET network after all traffic served by this switch is migrated to the CBET MetaSwitch 2 EVDLOHEVPS2 for DS0 Trunks and EVDLOHEVPS7 for T1 and T3 Trunks, both located at 1000 Reading Rd, Evendale, Ohio 45241.

## Description of Reasonably Foreseeable Impact of the Planned Changes: All carriers, including competitive local exchange carriers (CLECs), interexchange carriers (IXCs), ILECs, wireless carriers, and paging carriers will need to augment existing or provision new direct end office trunk groups to support traffic re-routing to the Evendale, Ohio MetaSwitch (EVDLOHEVPS2). ASRs should reflect CLLI EVDLOHEVPS7 for T1 & T3 facilities and reflect EVDLOHEVPS2 for trunking/DS0s. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Hamilton, Ohio DRM switch (on or after December 10, 2024). (This will serve to guide the re-homing of traffic for the NPA-NXXs currently served by the Hamiton, Ohio switch to the Evendale, Ohio MetaSwitch.)
